Contest Rules.

Article 1 Preamble

The international competition is open to all individual amateur photographers or members of photo clubs, excluding the organizing members of the FPSP festival.

The theme of the 2024 competition is "Street Photography".

120 photos selected (slideshow) / 40 exhibited (Interior & exterior)

The exhibition will take place during the Saint Pathus Photo Festival in **October 2024** (dates to be confirmed)

Article 2 Sections and Definition

Contestants can submit photos (up to 3) in digital format in a single category:

- **Monochrome and/or color**

Maximum number of photos: 3 per author

Article 3 Presentation and identification of photos

They will be offered in a JPEG format limited to 3MB (sRGB profile recommended) with a size of 1920 pixels * 1920 pixels (with one of the dimensions of 1920 pixels) and will be presented in the reading direction.

Each work will be named as follows:

- Name and surname of the author,
- Title and serial number of the registration form.

Photos that do not comply with the above standards will not be judged or exhibited.

All photos must be free from any coercion and must not in any way infringe the rights of any natural or legal person. The organizers can in no way be held responsible for any disputes or disputes.

Article 4 Dispatch

Article 5 Responsibilities

The organizers undertake to take the greatest care of the files as well as the printouts for the selected photos, but will decline all responsibility in the event of damage, loss or theft of the images sent.

Article 6 Judgment

A panel of judges will determine a ranking in an online judging process that will be the benchmark for the awards.

However, only one prize (1st, 2nd or 3rd) will be awarded per author.

The jury will be made up of people from the world of photography, the municipality and partners. It will meet behind closed doors and proceed to classify the best shots within the exhibition capacity limit.

The winners will be notified individually and the files in print format will be requested, depending on the prize. These files must be received by the organizers one week after receipt of the email announcing the results.

Article 7 Dotation

1er prix : 1 appareil photo GRIII ou GRIIIx (Ricoh Imaging) + tirage Dibond 60x90 (photokub)

2nd prize : Accessory kit for GRIII or GRIIIx (Ricoh Imaging) + Dibond print 60x90 (photokub)

3rd prize : 1 year subscription to Studio Jiminy + Dibond print 60x90 (photokub)

4th to 13th prize : Dibond print 60x90 (photokub)

14th to 40th prize: 40X60 paper print (photokub)

Article 8 Exhibition

The photographs will be exhibited in **October 2024 (dates will be confirmed on the website and social networks)** including different locations. As the winners were unable to make the trip, the prizes may be awarded to a person of their choice. In case of non-collection on the same day, the first and second prizes (prizes) will not be sent; it will be made available at the Town Hall of Saint Pathus or at the Ricoh Imaging Square Paris.

If the prize is not collected two months after the results are announced, it can be put back into play for the next festival.

The prizes awarded cannot be contested, exchanged or compensated for any of any kind.

Article 9 Accord

The participant guarantees the organizers that he/she is the exclusive author of the photos and that he/she holds the rights and authorizations of use thereof and in particular the right to the image and for this purpose he/she will provide supporting documents if necessary.

Article 10 Use

Unless otherwise instructed by the participant, the organisers reserve the right to reproduce the events presented, for the purposes of the event, for promotional or retrospective purposes, without commercial purposes, for a period of three years and without any claim to copyright.

The winning pictures can be reproduced on the website of the "Saint Pathus Photo Festival", and the Saint Pathus town hall. As well as on the associated social networks and those of the partners.

Article 11 Right of reproduction

Unless otherwise notified in writing by the author, the organisers reserve the right to reproduce the photos exhibited in the interest of the event, indicating the name of the author.
